Tree Report: Put out a communication regarding the worms on the trees. We have contacted Arborist and talked to a specialist at Unique Garden Center. Both have confirmed that the mature trees should be okay but will just look ugly for a while. The trees will re leaf. Infestation is wide spread and due to the milder winter we experienced. Leave the grass along the nursing home and north of Assiniboia grow longer to allow for song bird nesting per Wes Bailey's request.
